Our Clubs

- 95 clubs across Canada, including two virtual clubs: CFUW Canada-GWI Club and an E-Club
- Clubs range in size from 3
 (Pictou County, NS) to over 400 members
 (Ottawa)
- 41 Opt-in clubs supporting Graduate Women's International (GWI)
 - 56 Opt-out clubs
 - over 6600 members in total

What Clubs Do

- Promote Education and Lifelong Learning
- Raise funds for scholarships
- Speakers, study groups
- Address Advocacy Local, Provincial, National and/or International issues

- Stay relevant and responsive to members' needs and concerns
- Most organize monthly meetings



British Columbia

- 21 active clubs
 - Vancouver Island: 6, Interior: 4, Lower Mainland: 11
- BC Clubs are very active in highlighting Advocacy Issues, such as Elder Care issues, Kinship Care, Violence against Women, Affordable Day Care, Issues for youth in and aging out of Foster Care.
- All Clubs support education for women and girls through the provision of local scholarships
- Diverse connections and interests some with local Indigenous Women, concern for the women of Bounty and High School education for girls in Africa to name a few.

The Prairies

Alberta (5 clubs)

- Input into provincial budget priorities
- Advocacy related to ensuring effective health care
- Active with scholarship & bursary programs at club level

Saskatchewan (3 clubs)

- New bursary: New Beginnings Grant (1 provincial grant \$5,000)
- CFUW has the right to appoint a representative to the University of Regina Senate and does so every three years

Manitoba (1 club)

- The 1919 meeting organizing CFUW was held in Winnipeg
- Active with speakers, programs, scholarships & awards



Ontario

- 48 active clubs in 6 Regions. All celebrate the pride of diverse characteristics!
- Ontario Council Clubs are strong supporters of CFUW aims, and actively share the cornerstones of education and lifelong learning and advocate for women on today's issues.
- Ontario Council Clubs proudly represent CFUW in their local communities.

Atlantic Region

- 9 clubs: New Brunswick: 3, Nova Scotia: 4,
 Prince Edward Island: 1, Newfoundland & Labrador: 1
- Several clubs have highly successful book sales (one over \$70K) for scholarships, bursaries, fellowships; one club set up a Charitable Trust Indigenous Women's Award; Total awarded about \$120 K annually
- Libraries, Creative Arts, Advocacy & Community Outreach well supported by clubs; CT awards won in last two years

- Wrote two Resolutions that became CFUW Policies recently
- Strong history of commitment to CFUW (one club celebrating 100 years in 2024, 6 others over 65 years)
- Strong support for Life long learning through speakers & interest groups
- 50th Anniversary of a very successful club investment group (generally outperforming the TSX)—a charter member is still actively involved in the investment group

Membership Dues

- Two classes of Member Full and Student
- Each Club establishes its own Membership dues but all Club dues include an amount payable to:
 - National CFUW
 - Provincial Council
 - GWI (if club is supportive)
 - Insurance
 - Local Club
- These dues are paid to your local Club.
